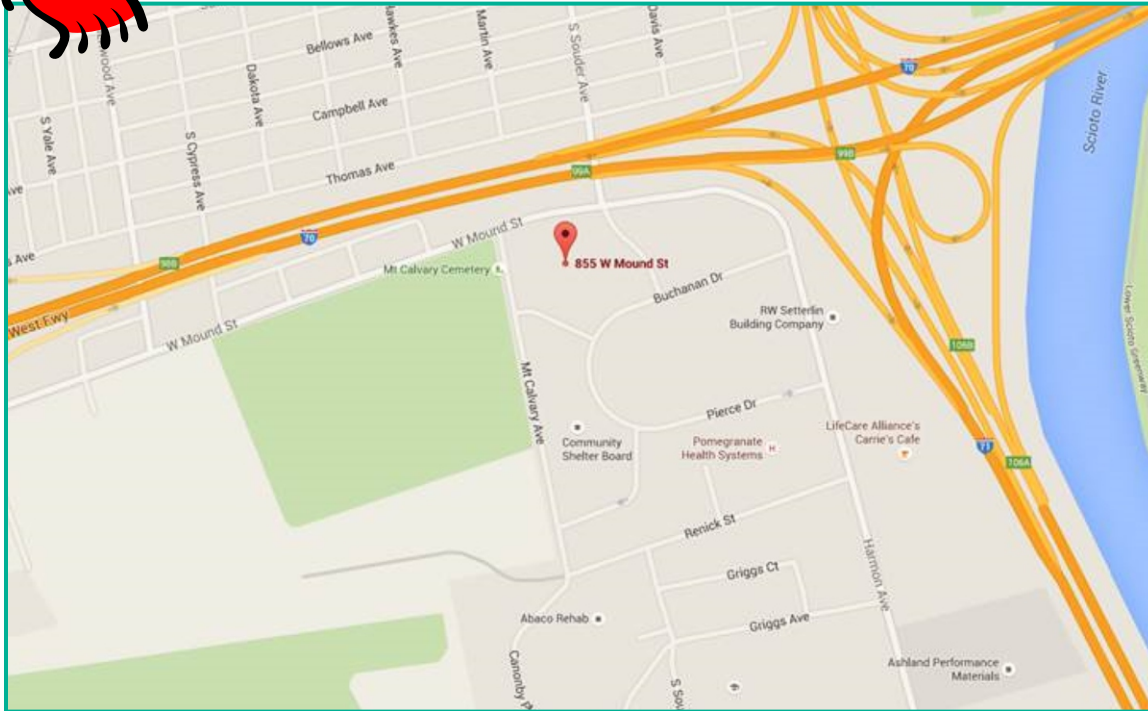




# DIRECTIONS & PARKING:

The Franklin County Children Services Administration Building is located on the corner of West Mound Street and Mt. Calvary Avenue. (Look for the big blue "W" sign for the West Edge Office Park.) The address is 855 West Mound Street, Columbus, Ohio 43223. It is easily accessible by car or bus. A map and simple directions are below.



**HOURS OF OPERATION**  
**Monday-Friday**  
**8:00am - 5:00pm**

**ALL VISITORS TO OUR BUILDING WILL BE REQUIRED TO WEAR A MASK.**

**From the North:** 315 South to 70 West or 71 South to 70 West. 70 West to Mound St. exit 98B. Turn left onto Mound. Make a right onto Mt. Calvary Street. Make a left onto the property into the parking lot.

**From the South:** 71 North to 70 West to Mound St. exit 98B. Turn left onto Mound. Make a right on Mt. Calvary Street. Make a left onto the property into the parking lot.

**From the East:** Take 70 West to Mound St. exit 98B. Turn left onto Mound. Make a right on Mt. Calvary Street. Make a left onto the property into the parking lot.

**From the West:** Take 70 East to Broad Street. Make a left onto Broad Street. Right onto Glenwood (right after you go under the overpass). Make a left onto Mound St. Make a right on Mt. Calvary Street. Make a left onto the property into the parking lot.

**Parking:** Visitor parking is available on the south side of the building. Overflow parking is available across Van Buren Street as well. **There are several parking spaces marked for Holiday Wish Donors.** Please let us know if you need help bringing gifts into the building; we are more than happy to assist!

Visitors to Holiday Wish should use the Holiday Wish entrance located on the south side of the building.
